RENTAL CONTRACT

to purchase it. **The value of this instrument** \$_____ You may return the instrument at any time during the contract. There is a 3 month Minimum rental. At the end of this rental contract if the account is current, no further rental payments will be charged. However, you do have an option to purchase the rental instrument as more fully described below.

Rental payments are to be paid **every three (3) months** from the original date of the contract. Additional payments of the same amount will be due in advance on the same date for each three (3) month period thereafter. If the instrument is returned, all unused whole monthly rents will be refunded. **The quarterly rental of \$ _____** applies to the purchase of the instrument provided that you are current with those payments and not in default of any terms or conditions of this contract.

In the event that you default under any terms of conditions of this contract, this option to buy shall be void, the payments previously made shall not apply toward purchase and **the instrument must be returned**. If the account is in default, 24% per annum (2% per month) will be added to the unpaid balances as well as any costs incurred incident to collection of the debt, including any attorney's fees.

If payment is not received within **ten (10) days from the due date a late fee of \$10.00** will be added to any outstanding balance or unpaid charges. If we need to visit the house to pursue collection of unpaid amounts, there will be a **\$50.00 fee per visit**. Upon default of this contract, the necessity of which requires the use of an attorney, you will be charged 20% of the total value of this contract for such attorney's fees plus any additional fees incurred.

You are not entitled to remove the instrument from the Washington, D.C. area, except for short incidental trips or sell it as long as this contract is in effect.

MAINTENANCE-INSURANCE PLAN

The Maintenance-Insurance plan described below has been made available to provide for routine maintenance of your rental instrument including coverage of loss/theft. The nominal fee for this service, payable with your rental payments, will protect you throughout the entire time you rent your instrument.

COVERAGE: Repairs due to normal usage of the instrument, including pads, corks, bent keys, minor dents, cleanings, and labor costs. Parts such as screws, keys, joints, mouthpieces, ligatures, or other disposable accessories (reeds and oils) are the responsibility of the renter. Intentional damage to the instrument is considered negligence and therefore the renter is responsible for all repair/replacement costs. Should the instrument become lost or stolen, a police report must be filed within 24 hours of the incident. A copy of the police report must be submitted to L & L Music-Wind Shop, Inc. no later than 5 business days from the date of the report. The renter is required to recompense L & L Music-Wind Shop, Inc. should they be awarded funds for the disappeared instrument from a private insurance. If these above outlined protocols are not followed, L & L Music-Wind Shop, Inc. retains the right to bill the renter for the balance due on the rental.

If it should become necessary for our shop to keep your instrument for more than 7 days to complete proper repair, an instrument will be loaned to you so that valuable practice and instruction time will not be lost.
